- 1. The best way to verify income is by using the IRS Data Retrieval Tool option within your FAFSA.
- 2. If you cannot use the IRS Data Retrieval Tool, you may obtain a Tax Return Transcript using these methods: On-line or by mail at <a href="www.irs.gov/Individuals/get-transcript">www.irs.gov/Individuals/get-transcript</a> or order by phone: **1-800-908-9946**. Please note the IRS TAX RETURN TRANSCRIPT is the ONLY document that we can accept to verify tax return data.
- 3. If you DID NOT FILE a tax return: Please provide our office with a Verification of Non-Filing Letter from the IRS for those that did not file a 2022 IRS tax return. Request this letter by contacting the IRS at <a href="https://www.irs.gov/individuals/get-transcript">https://www.irs.gov/individuals/get-transcript</a>.
