- 1. The best way to verify income is by using the IRS Direct Data Exchange (DDX) option within your FAFSA.
- 2. If you cannot use the IRS DDX, you may obtain a Tax Return Transcript using these methods: On-line or by mail at <a href="www.irs.gov/Individuals/gettranscript">www.irs.gov/Individuals/gettranscript</a> or order by phone: 1-800-908-9946. Please note the IRS TAX RETURN TRANSCRIPT is the ONLY document that we can accept to verify tax return data.
- 3. If you DID NOT FILE a tax return: Please provide our office with a Verification of Non-Filing Letter from the IRS for those that did not file a 2023 IRS tax return. Request this letter by contacting the IRS at <a href="https://www.irs.gov/individuals/get-transcript">https://www.irs.gov/individuals/get-transcript</a>. - 4. If you, the student, worked AND /OR had taxable income but did not file and are NOT REQUIRED TO FILE: Complete the Student Non-Filer form SNF26, W2(s) and submit with documentation and IRS Verification of Non-Filer letter if available.
- 5. If you intend to email or fax your documents, to meet our security protocols, please mark out all but the last 4 of your social security number from all documents. *Always include student name and CofC ID number on documents submitted.*
