Based upon the following determination, the proposed procurement action described below is being procured pursuant to the authority of Section 11-35-1560 of the SC Procurement Code and 19-445.2105 of the Rules and Regulations, 1976 SC Code of Laws.

Why does the governmental body need this item or service: (description of the agency need that this procurement meets):

To properly analyze the organic macromolecules produced in Dr. Van Horn's research, a GPC needs 1) the dual-flow refractive index detector with a continuous flow through cell, 2) two isocratic pumps that operate independently through the RI detector, and 3) the system must be temperature controlled from sample injection through pumps, autosampler, RI detector and solvent system to waste for best data collection and analysis.

Market research through Procurement IQ and GovSpend did not provide any findings. However, research using Google did confirm that this system is proprietary to Tosoh and they are only source for purchasing it.

A EcoSEC Elite GPC (gel permeation chromatography) system for polymer research analysis.

There are other manufacturers that offer GPC systems that contain some of these elements and most have parts of the GPC that are temperature controlled and parts that are not. Tosoh EcoSEC Elite is the only system that has all three of these criteria in one instrument with temperature control from start to finish.
