We went through the RFP (Request for Proposal) process twice and no other organization was able to fulfill our requirements. Those RFP's were closed without awarding.

Meltwater tracks the world's largest database of news sources at 350,000+ global news sources, over 8,500 print/paywall media sources, broadcast media from all 210 US DMA's (content from strategic partnership with TVEyes) in both local, national and cable outlets, along coverage from around the world, major social media (ie Facebook, YouTube, Twitter, Instagram, Message Boards, Reviews, Reddit, Forums, etc.) and over 200+ million blogs/microblogs.

Detailed explanation why no other vendor's supplies, construction, information technology, and/or services will meet the needs of the Agency:
Other companies do not fulfill the total requirements outlined in our RFP. Meltwater offers an app and also an extensive media outreach database. The other services focused mainly on social media monitoring.
