Based upon the following determination, the proposed procurement action described below is being procured pursuant to the authority of Section 11-35-1560 of the SC Procurement Code and 19-445.2105 of the Rules and Regulations, 1976 SC Code of Laws.

Why does the governmental body need this item or service: (description of the agency need that this procurement meets):

Per the CAA, we must offer replay for men's and women's basketball to compete in that sport in the conference. It also must be used if replay is used in volleyball.

As a sole source procurement for \$ 38,541.40

Description of market research Agency has performed to determine the availability of products or services that would meet the Agency's needs:

Market research through Procurement IQ and GovSpend did not provide any findings. However, research using Google did confirm that this replay system is proprietary to DVSport and they sell direct to the end-user. There are other systems on the market, however the College is contractually obligated with the CAA to purchase the DVSport system.

Description of supplies, construction, information technology, and/or services Vendor will provide under the contract:

Six-input replay system with basketball software included: Camera Kit for Capturing the Clock in Basketball, DVSport 360 Annual Subscription - Basketball Only

Monitor case: Three monitors - two 24" touch monitors and one 7" monitor; Keyboard, mouse, and mousepad; Technician controller; Clock cables and adapters; Cable and power cords

This sole source is for a five year period. The estimated annual cost is \$38,541.40 with a total estimated five year cost of \$192,707.

Detailed explanation why no other vendor's supplies, construction, information technology, and/or services will meet the needs of the Agency:

The College has a contractual obligation with CAA to purchase this system for use of replay at basketball and volleyball games.

In accordance with the South Carolina Consolidated Procurement section 11-35-1560 - Sole Source, the College of Charleston announced the intent to award without Competition. No protests were received.
