Description of market research Agency has performed to determine the availability of products or services that would meet the Agency's needs:

Market research was conducted by the IT department, which found no other company offers a comprehensive suite of features in a single product as VoiceThread does. Specifically, VoiceThread has a multi-modal commenting feature, which other vendors do not possess. Further, market research via Procurement IQ, GovSpend, and Google has confirmed that VocieThread is the sole provider of their product.

VoiceThread site license with platinum service including VoiceThread Active User License NEW Higher Ed with 8000 Active User band

Detailed explanation why no other vendor's supplies, construction, information technology, and/or services will meet the needs of the Agency:

VoiceThread is deeply embedded into the academic ecosystem at the College, especially within the online learning environment, allowing faculty and students to create multimedia presentations with images, videos, and documents and then have an integrated, multimodal discussion through voice (computer microphone and phone), video, or text. The multi-modal commenting feature is unique to VoiceThread. It is also integrated within the Learning Management System. VoiceThread also has the ability to automatically close caption the presentations, supporting the Universal Design of Learning principles.
