Why does the governmental body need this item or service: (description of the agency need that this procurement meets):

Executive coaching is required for students enrolling in the Executive MBA Program that begins in January 2025. Executive coaching plays a vital role in enhancing the leadership capabilities of executives, providing them with the tools and support needed to succeed in their current and future roles. Wisdom Works will provide this coaching piece to the program as experts in the field without burdening the program with the creation of a coaching program and assessments. The College of Charleston does not have access to the assessments they created without a partnership.

Description of market research Agency has performed to determine the availability of products or services that would meet the Agency's needs:

Market research through Procurement IQ and GovSpend did not provide any findings. However, research using Google found that these assessments are proprietary to Wisdom Works Group.

## Description of supplies, construction, information technology, and/or services Vendor will provide under the contract:

Under their guidance, the EMBA participants will receive two assessments at the beginning of the course, a series of coaching hours over the 18 months and two re-assessments at the conclusion of the course to capture results. The outcomes for this section are a.) awareness and understanding of leadership competencies and the science of wellbeing leadership psychometrics; b.) development of individual competencies for personal transformation; c.) experienced practical ways to authentically embody wellbeing and understand how to create environments for thriving in self and others.

They will be using two very specific assessment systems:

- 1. Leadership Circle Profile
- 2. Be Well Lead Well Pulse®
