Market research through Procurement IQ and GovSpend did not provide any findings. However, research using Google found that this security equipment is proprietary to Sonitrol Security Systems and they are the only authorized source to service it.

Sonitrol alarm system monitoring, notification, and equipment to include routine maintenance, inspections and repair.

This sole source is for a five-year period. The estimated annual cost is \$64,459.24 with a total estimated five-year cost of \$322,296.20.

Sonitrol installed the equipment and is proprietary to them. Equipment will not interface with any other alarm systems, thus Sonitrol is the only vendor who can provide these services.
