Why does the governmental body need this item or service: (description of the agency need that this procurement meets):

This is needed to advertise the College's MBA program at the Charleston International Airport. This is the major airport in the Charleston area. Over six million people travel through it, which makes it an ideal location for marketing. Airports attract a diverse group of people from different backgrounds, including business travelers, tourists, and international passengers, providing exposure to various market segments for the MBA programs. Travelers often have significant downtime while waiting for flights, security checks, and baggage claims, making them more likely to notice and engage with advertisements.

This is a custom full-color wall banner (294.125" wide x 159" tall) hung in the main atrium in the Concourse B Entrance advertising the MBA programs at the College of Charleston.
