College of Charleston Statement on Sexual Misconduct

It is the policy of the College of Charleston to respect the rights and dignity of the individual. Sexual misconduct, including sexual violence and sexual harassment, violates this principle and will not be tolerated. College policy prohibits discrimination and harassment based on any protected status including sex, sexual orientation or gender identity and expression.

Sexual misconduct can include sexual harassment, gender-based harassment, non-consensual sexual contact, non-consensual sexual intercourse, intimate partner violence (domestic and dating violence), stalking and sexual exploitation.* The College is committed to taking immediate, equitable and effective steps to eliminate sexual misconduct, to prevent its recurrence and to address its effects.

We encourage members of the campus community who experience any form of sexual misconduct to contact one of the persons or offices contained within this pamphlet, which may help members of the campus community to explore available resources, such as physical and emotional support, as well as reporting and hearing options, including filing a complaint through the College of Charleston and/or the City of Charleston Police Department or other law enforcement agency.
