

Substantive Change Planning

The SACSCOC Liaison is responsible for informing SACSCOC of any substantive changes at the College of Charleston through notification or seeking of approval. Such modifications are described in the SACSCOC Substantive Change Policy and must be made prior to implementation. In order to ensure adherence with this policy, please answer this form, so as to provide OIEP with the pertinent information.

Definitions

- Consortial relationship typically is one in which two or more institutions share in the responsibility of developing and delivering courses and programs that meet mutually agreed upon standards of academic quality.
- Contractual agreement typically is one in which an institution enters an agreement for receipt of courses/programs or portions of courses or programs delivered by another institution or service provider.
- Distance education a formal educational process in which the majority of the instruction (interaction between students and instructors and among students) in a course occurs when students and instructors are not in the same place. Instruction may be synchronous or asynchronous.
- Dual program a program whereby students study at two or more institutions and each institution grants a separate academic award bearing only its name, seal, and signature.
- Joint program a program whereby students study at two or more institutions and the institutions grant a single academic award bearing the names, seals, and signatures of each of the participating institutions.
- Program any transcripted credential offered by the College to include bachelor's degrees, master's degrees, doctoral degrees, other professional degrees (J.D. M.D., etc.), graduate certificates, and undergraduate certificates.
- Significant departure a program that is not closely related to previously approved programs at the institution or site or for the mode of delivery in question.
