SCTS 4.0 data is limited to Annual 1 contract teachers (i.e., teachers undergoing formal evaluation) who graduated in the past seven years. State-wide, 93.03% of Annual 1 contract teachers passed evaluation during the 2021-22 academic year. During that same year, 92.79% of our EPP graduates passed formal evaluation. Our EPP passing rate was statistically similar to the state passing rate $X^2(1, N = 2034), 0.01, p < .05$.
