

Recommended for Licensure

CofC EPP recommends program completers for teacher licensure if they have met South Carolina Department of Education (SCDE) requirements and have passed all Praxis II required tests for their licensure area(s). Table 1 illustrates the number and percentage of program completers recommended for licensure to the SCDE for the identified academic year in which they completed the program. It also identifies the number of program completers who were not recommended and the reason why they were not recommended.
